

Hurricane provides both "full" and "do it yourself" yard services. Under "full" services we perform work on your boat to your specifications on a time and materials basis. Time is accounted for to the fourth of an hour by task performed and all materials consumed are itemized.

For the "do it yourself" client we haul your vessel, power wash the bottom, then block it so you can do the work yourself. If some portion of the work requires special tools or crafts, our personnel can assist on a time and materials basis. **NO outside contractors or client employees are allowed to perform work on any vessel unless authorized by the yard manager. Labor is to be provided by the owner or his family on a hold harmless basis. Any person using outside workers and/or vendors to perform work on your vessel will be charged \$30.00 per day per man.**

Free consultation is available from our yard manager. Our mechanic, carpenter, rigger, fiberglass and painting craftsman will log their consultation time (formal and informal, during working and personal hours) on a 15 minute basis to your account, when you use their time. They are clocked onto a specific job when out and about on the yard and it is only fair to that client that they not be interrupted.

**We stock most of the supplies you need at competitive prices. We can order many items with next day delivery if we don't have it in stock.** You may use your own supplies, including paint. You are responsible for clean up and hauling off your own trash. **For household trash ONLY there is a trash receptacle located by the office entrance.**

**Live aboard Fee**.....\$8.00 per day for up to 2 people  
(Includes Hot shower, bathroom).....more than 2 people, additional \$5 each

**Dry Storage**.....\$200.00 per month up to 36 feet  
\$5.50 per foot for each additional foot

Storage rate includes one (1) 30 amp electrical service. During extreme weather, hot or cold, all vessels using electrical service are subject to an additional charge. For additional electrical service see Office Staff. Long term storage can be provided on a limited basis for fully found, properly maintained vessels. **All boats are to carry Port Risk Insurance as a minimum.**

Hauling charges are in addition to the storage and work space rate. We bill on a monthly basis and payment is due monthly unless other arrangements are made with the Office Staff. No work will be performed or allowed on vessels more than 30 days in arrears.

**GENERAL YARD RULES AND REGULATIONS:**

1. NO ALCOHOL ALLOWED ON THE YARD.
2. Owner of any vessel with an outstanding balance for more than 180 days acknowledges transfer of ownership to Hurricane Boatyard. Hurricane Boatyard, at that time will exercise rights of ownership of said vessel as management deems appropriate.
3. Any account
4. No outside labor or independent contractors are allowed unless permission is obtained from the Yard Manager. All contractors performing work on a vessel in the boatyard must have a Certificate of Insurance on file with the Office, showing liability insurance in the amount of \$1,000,000.00 and workmen's compensation coverage on each person working on boatyard property.
5. All boats must have hull and liability insurance. The yard is not responsible for damages due to fire, storms, thefts, winds, ice, acts of God, outside laborers, or the work of independent contractors. The owner agrees the yard will not be liable in the event of such an occurrence.
6. Larger jobs that are material intensive will require deposits and payments as work progresses.
7. In the event of a severe storm, the yard will attempt to provide preparation and damage prevention service. However, the owner is still solely responsible to take all emergency means possible and the yard does not assume any responsibility for said protection or damages to the owner's boat.
8. Key or hatch combination must be left with the Yard Office.
9. No fires permitted on docks or boats.
10. No dogs allowed in the yard.
11. Owners are not to change boat blocking or stands without assistance of yard personnel. Stands are moved free of charge by boatyard personnel.
- 12. WORK AREAS MUST BE CLEANED DAILY OR A \$40.00 CLEAN-UP FEE WILL BE CHARGED.**
- 13. NO BOATS WILL BE LAUNCHED UNTIL BILLING IS PAID IN FULL.**

**Long-term storage**—Workspace rent is due the first of the month. Final payment for non-local boats before launch must be cash or certified fund.
